Current Situation:

Public Health – Dayton & Montgomery County, the Ohio Department of Health (ODH) Centers for Disease Control and Prevention (CDC) and World Health Organization are closely monitoring an outbreak of respiratory illness caused by a novel (new) coronavirus (termed "2019-nCoV") first identified in Wuhan City, Hubei Province, China in December 2019 and which continues to expand.

Current Public Health-Dayton & Montgomery County Updates:

- Public Health will continue to coordinate efforts with ODH and CDC.
- Public Health will continue to respond to all media requests.
- Public Health and County officials will provide an overview of preparedness measures being taken for the coronavirus on January 30, 2020 at 2 PM.
- Public Health has scheduled a conference call with the other local health departments' in the West Central Ohio (WCO) region for January 30, 2020 at 3 PM to discuss shortterm and long-term planning concerns.
- Public Health continues to identify employees that could be reassigned to support an informational hotline if the need arises.
- Public Health has shared a Q & A with Help-Link 211 covering general questions for coronavirus.
- Public Health partnered with Dayton MMRS and Greater Miami Valley EMS Council to produce bulletins for public safety (fire, EMS, law enforcement).
- Public Health has updated all on-call staff with the latest information concerning PUI cases as well as basic Q & A information on coronavirus.
- Public Health will continue to share the situational report with other local health departments, Montgomery County Emergency Management, Greater Dayton Area Hospital Association and Dayton Metropolitan Medical Response System partners.

CDC Response Updates:

- The goal of the ongoing U.S. public health response is to contain this outbreak and prevent sustained spread of 2019-nCov in this country.
- CDC and Customs and Border Protection (CBP) are continuing to conduct enhanced entry screening of passengers who have been in Wuhan within the past 14 days at 5 designated U.S. airports. Given travel out of Wuhan has been shut down, the number of passengers who meet the criteria are dwindling.
- Going forward, CBP officials will monitor for travelers with symptoms compatible with 2019-nCoV infection and a travel connection with China and will refer them to CDC staff for evaluation at all 20 U.S. quarantine stations.
- At the same time, ALL travelers from China will be given CDC's Travel Health Alert Notice, educating those travelers about what to do if they get sick with certain symptoms within 14 days after arriving in the United States.

- Four confirmed cases reported in United Arab Emirates, in individuals traveling from Wuhan City.
- World Health Organization (WHO), in collaboration with the World Economic Forum, has set up a public private collaboration called "The Pandemic Supply Chain Network (PSCN)". It is a Market Network that seeks to provide a platform for data sharing, market visibility, and operational coordination and connecting.
- Today, PSCN is launching the first of several teleconference calls with over 350 private sector organizations and 10 multilateral organizations to develop a market capacity and risk assessment for personal protective equipment (PPE). This assessment will be used as the basis to match the global demand for PPE with the global supply. The market and risk assessment for PPE is expected to be completed by 5 February 2020.
- The Emergency Committee on the novel coronavirus (2019-nCoV) under the International Health Regulations (IHR 2005) is re-convened by the World Health Organization Director-General Dr. Tedros Adhanom Ghebreyesus on 30 January.

Ohio Department of Health Update:

- ODH held another state-wide call to share information with local health departments and other response organizations.
- ODH continues to stress that the US is considered a low-risk environment.
- Ensure messaging to all LE/Fire/EMS.
- Specimens for Patient Under Investigation (PUI) from Butler County is at CDC.
- Travel history needs to be as specific as possible.
- ODH has established a virtual JIC the number is 614-644-8562.

- Provide essential information and updates to reduce racism and poor treatment of PUI's.
- Have support from multiple partners during press conferences.
- There will be another call with the state tomorrow at 9 AM.

Current Threat Status:

Warning Level 3, Avoid Nonessential Travel.

CDC recommends that travelers avoid all nonessential travel to China.

Current Objectives:

- 1. Continue surveillance efforts of any possible cases.
- 2. Continue to monitor the situation in conjunction with the Ohio Department of Health and the Centers for Disease Control and Prevention.
- 3. Continue information sharing with partners.
- 4. Continue to provide information to the media and the public through interviews, social media and our website.

Long-term Planning Considerations:

Continued monitoring and maintaining surveillance locally.
